With full knowledge, comprehension & understanding of these dangers, I voluntarily accept & assume all risks involved in the spirit of competitive surfing. I will further read & comply with all ESA rules & regulations noting existing weather conditions & do agree that I voluntarily assume all risks arising from conditions related to sue of the contest site by myself & others. In consideration of your acceptance of my entry, I intend to be legally bound, hereby, for myself, my heirs, executors & administrators, hold harmless & release & forever discharge Ocean Surf Shop & their employees, The Eastern Surfing Association, Charleston County, SC, The City of Folly Beach, SC, the State of SC, all ESA National & local sponsors & event sponsors, their members, agents & any officials connected with this competition, from all liabilities for injuries & damages whatsoever, arising from any presence or participation in the above described event & do hereby grant the sponsors such release as described herein.
